The U. T. System Board of Regents will convene a Special Called Meeting by telephone conference call from 1:30 p.m. to approximately 1:45 p.m. on June 2, 2021, according to the following agenda. It is necessary to conduct this special meeting remotely because it was difficult or impossible to convene a quorum in one place in a timely manner and discussion and action on agenda matters is of sufficient urgency to be considered prior to the next regularly scheduled meeting of the Board on August 18-19, 2021. There will be no in-person participation for this special called meeting, which will be conducted virtually as authorized by Governor Abbott's Executive Order temporarily suspending certain provisions of the Texas Open Meetings Act, effective March 16, 2020, to address and mitigate the effects of the COVID-19 pandemic.

Agenda items are tentatively scheduled to follow each other consecutively but may start earlier or later than the posted time depending on the length of the discussions and the reports of previous items.
