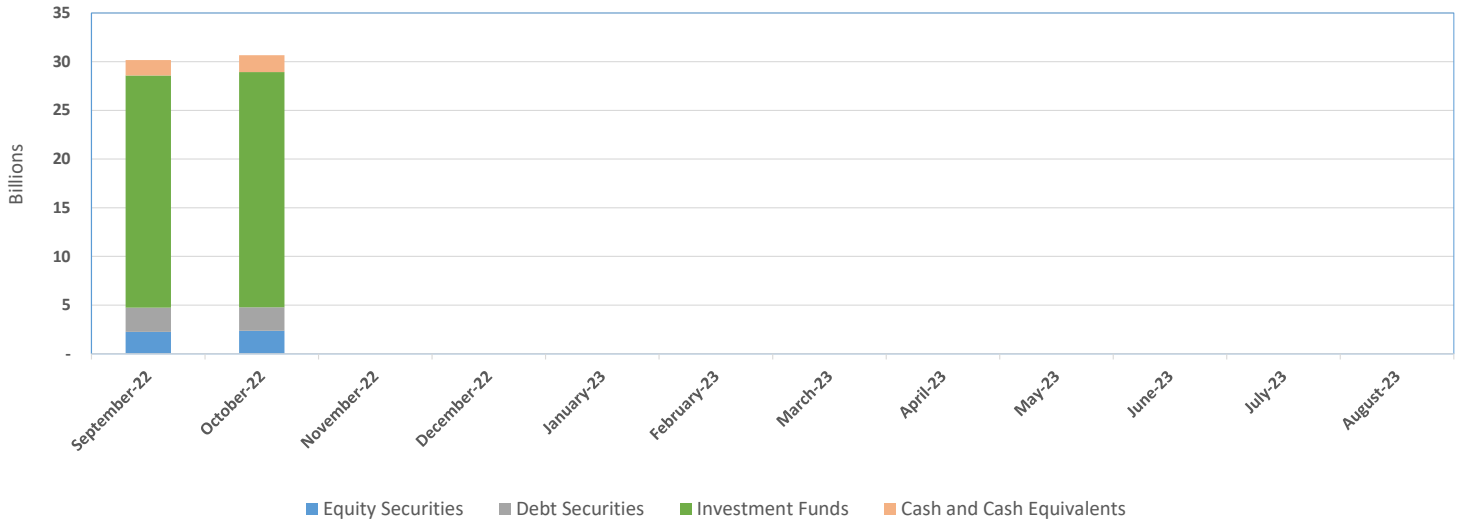


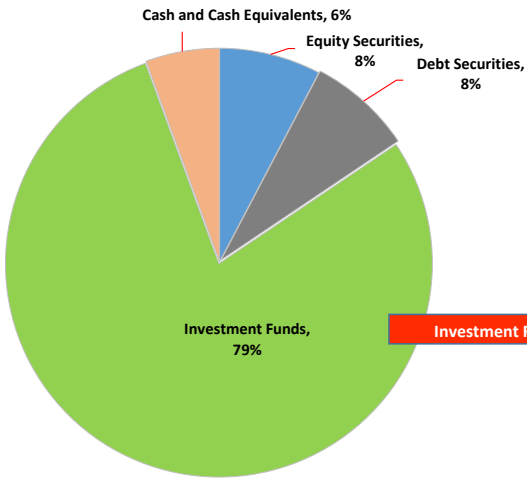

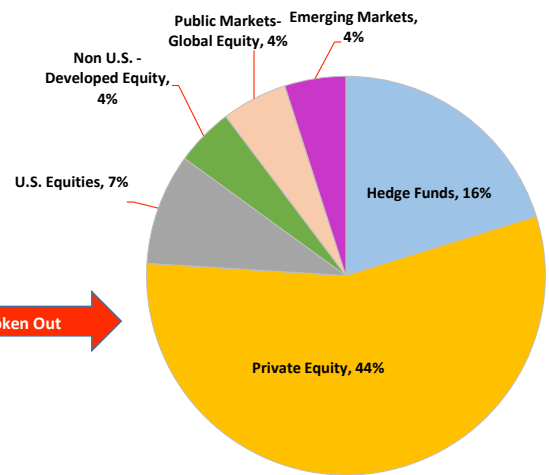
Investment Portfolio - FY 2023



Investment Portfolio as of October 2022

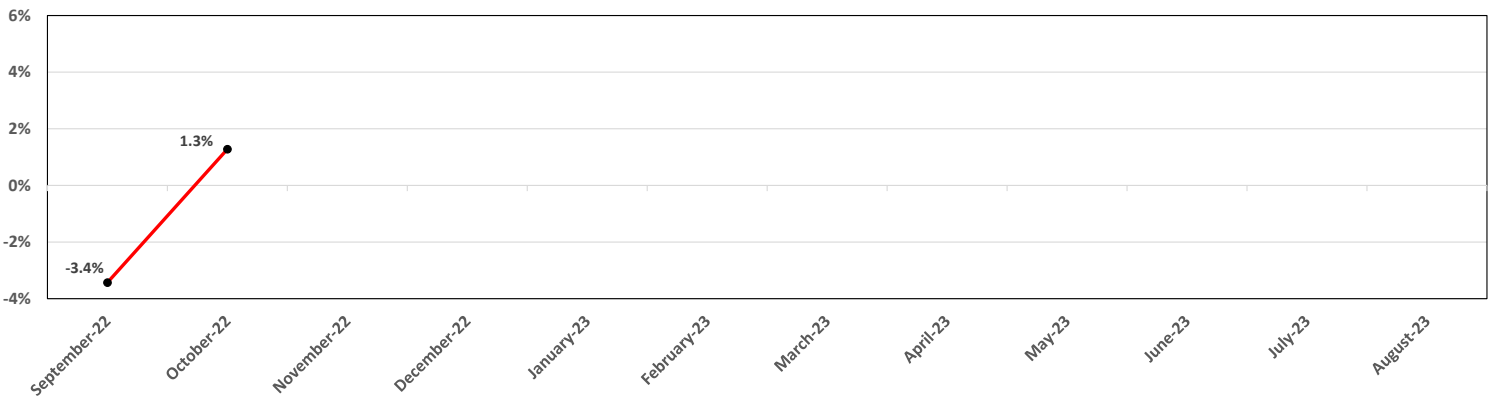


Investment Funds Breakout
